## **Product Usage Instructions**

## **Connecting the Multimedia Player**

To use the Showtop Multimedia Player, follow these steps:

- 1. Connect one end of the HD Video Cable (HDMI) to the HDMI port on the multimedia player.
- 2. Connect the other end of the HD Video Cable (HDMI) to your TV or display device.
- 3. If you want to connect external storage, insert a TF Card or USB device into the corresponding ports on the multimedia player.
- 4. If you want to use earphones, connect them to the Earphone port on the multimedia player.
- 5. If you want to connect to a network, use an Ethernet cable to connect the LAN port on the multimedia player to your router or modem.
- 6. Finally, connect the DC-12V power adapter to the multimedia player and plug it into a power outlet.

## **Using the Remote Control**

The remote control included with the Showtop Multimedia Player has various functions:

- Power Key: Press this key to turn the multimedia player on or off.
- Menu: Press this key to access additional features and settings on the current interface.
- Setting: Use this key to access the settings menu.
- **Home:** Press this key to quickly return to the home page.
- Enter: Press this key to confirm selections or open a selected item.
- Exit: Use this key to return to the previous menu.
- Voice volume: Adjust the volume of the audio output.
- **Direction:** Control the movement of focus in vertical and horizontal directions. In the playback interface, the left and right keys are utilized for fast forward and backward functions respectively.

## **FAQ**

#### What is the warranty period for the Showtop Multimedia Player?

The warranty period for the Showtop Multimedia Player is one year.

# What situations are not covered by the warranty service?

The following situations (but not limited to) are not covered by warranty service:

- The absence of the warranty certificate or valid invoice.
- Damage caused by improper use, maintenance, or storage of the product.
- Damage caused by natural disasters, such as fire, flood, lightning strikes, etc.
- The product model or code on the warranty certificate does not match the actual product.
- In the event of a complaint, you should seek resolution from the relevant responsible party or choose a paid service.
- Normal wear and tear during product use is not covered by the warranty.
- Consumer's own network issues that prevent product usage are not within the scope of after-sales service.

## What should I do if I need maintenance or repair?

If you require maintenance or repair, please follow these steps:

- 1. Record the details of the fault condition and cause of the fault.
- 2. Contact the authorized repair agent mentioned in the warranty certificate.
- 3. Deliver the product to the repair agent along with the necessary documents.
- 4. The repair agent will provide a delivery date for inspection and may assign a new serial number if required.
- 5. Once the maintenance is complete, the repair agent will provide a signed report and seal on the product.






