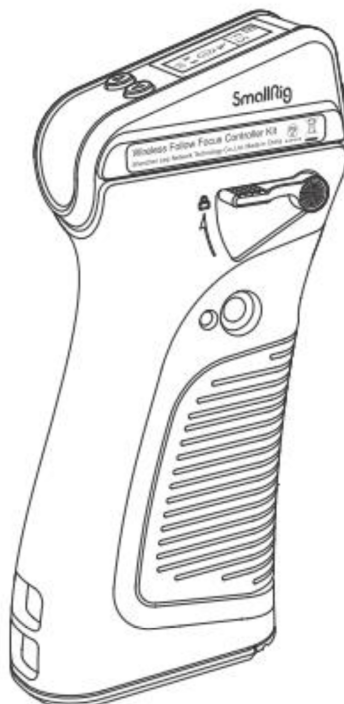

Please read this user manual carefully. Please do not use it in water. This product does not have the function of dustproof and waterproof.

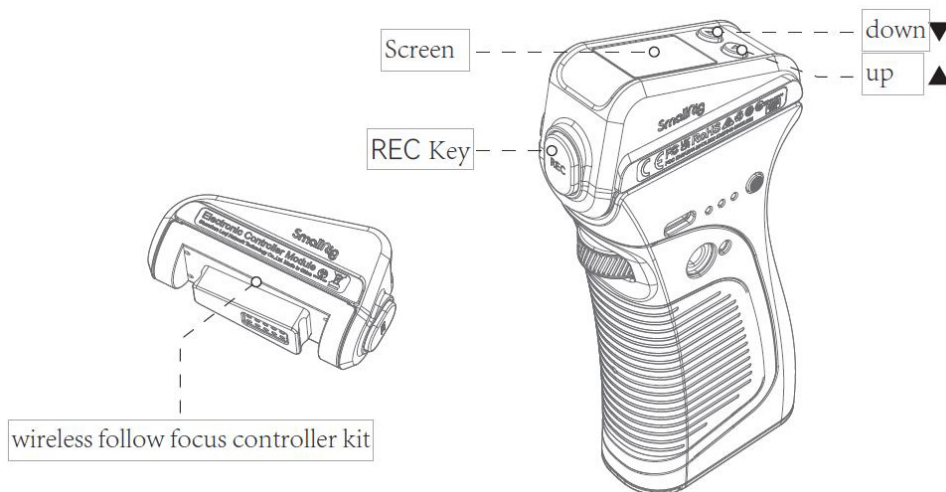

### REC key:

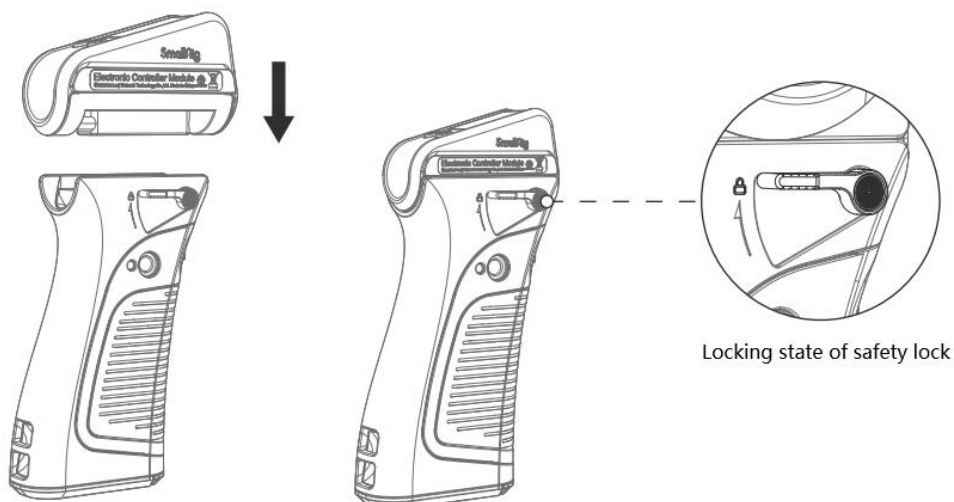
1. Start and stop REC recording

### Up/Down:

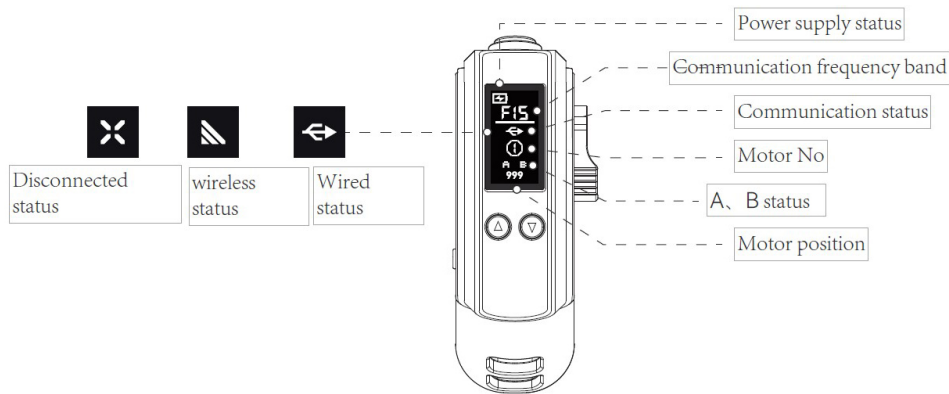
1. Frequency band adjustment

3. Turn pages up and down


