#### **NFR Renewals**

Standard, free of charge NFR orders are placed with a 12-month term and Sophos is automatically renewing \$0 NFR licenses for all partners in good standing.

For transacting partners, paid NFR renewal orders can be processed at NFR discount levels following the same steps as described in the "NFR Ordering Process" section above. Based on partner level, qualifying partners may be eligible for three-year renewal terms on NFR products. Please check with your local CAM or distributor for three-year term NFR renewal eligibility. Nonactive or inactive partners, as defined in the NFR Terms and Conditions section below, may not be eligible for NRF offerings or may be charged for NFR renewals.

- NFR promotional codes are valid for all switches, SD-RED, Wireless access points, and Firewall appliances (100 series and higher). Entry-level, XGS appliances below the 100 series are excluded.

  - Partner-led product demonstrations to prospective customers
  - Testing for internal use and training of the products with partner staff
  - Partner in-house production use to support its own infrastructure
