


Safety instructions





1. Turn on / off




2. Select mode





- To pair a different device, first disable Bluetooth on the connected device or press the Mode button for 3 seconds to re-enter pairing mode. Then repeat the pairing steps.
- Having connection problems? Remove SoundCore from your device's Bluetooth history, ensure it's less than 3 feet away then try pairing again.

b. AUX-In mode






