# **Product Usage Instructions**

# Charging

Connect the charging cable to the DC charging port of the device. Make sure to fully charge the device before initial use.

# Power On/Off and Mode Selection

To turn the device on/off, press the S button for 1.5 seconds. The device will enter default Mode 1. Press the S button to switch between 5 modes:

- Mode 1: Suction & Vibration 1
- Mode 2: Suction & Vibration 2
- Mode 3: Suction & Vibration 3
- Mode 4: Suction only
- Mode 5: Vibration only

#### **Status Display**

The status display indicates different states:

Low battery: Activate status
While charging: Light flashes
Fully charged: Permanent light

#### **App Connection**

To connect the device to the SVAKOM app:

- 1. Ensure Bluetooth is enabled on your phone/tablet.
- 2. Turn on the device and open the SVAKOM app.
- 3. The device should connect automatically.

# FAQ

- Q: What should I do before using a new SVAKOM device?
  - **A**: Before using a new SVAKOM device, make sure to fully charge it and clean it with mild unscented soap before using it on your body.
- Q: How can I connect the device to the SVAKOM app?




