## Product Usage Instructions

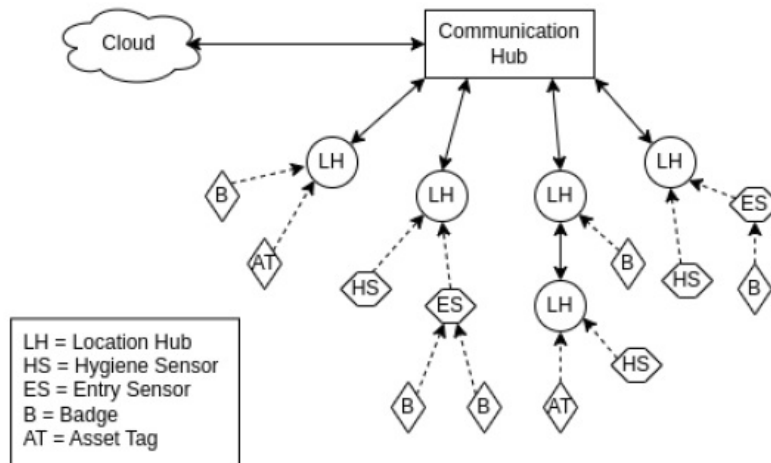
### System Description

The SwipeSense System combines point-of-care hand hygiene with real-time usage data to improve compliance with infection control procedures. The system includes the following components:

- Badges worn by employees
- Asset tags attached to tracked assets

- Hygiene sensors mounted to hygiene dispensers to track hand sanitation frequency
- Entry sensors installed indoor thresholds to provide real-time feedback
- Location hubs to monitor employee presence in patient rooms and asset locations
- Communication hub to collect and transmit data to the cloud

Once the data is uploaded to the cloud, it can be accessed by administrators.



## Product Description

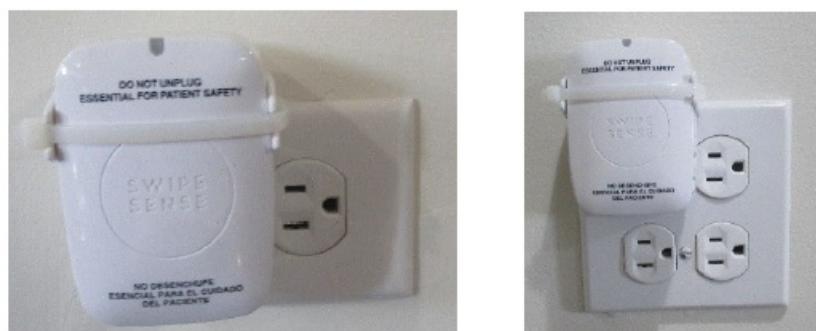


Figure 1: Installed Location Hub

The Location Hub Model 521.0 is a wall-mounted device placed inside patient and non-patient areas. It measures the signal strength of nearby badges and transmits the information to the communication hub for processing. It also acts as a powered relay node for Hygiene and Entry Sensors installed beyond the range of the communication hub alone. For a visual reference, please refer to Figure 1 in the user manual.

## Safety and Regulatory Information

This device complies with part 15 of the FCC Rules. Operation is subject to the following two conditions. (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

**Warning:** Changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment. This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

## System Description

The SwipeSense System combines point-of-care hand hygiene with real-time usage data to eliminate dependency on manual observations and increase compliance with infection control procedures. Our fully integrated system seamlessly provides real-time hand hygiene data from across the enterprise with exceptional clarity. The SwipeSense System creates a "mesh network" that provides flexibility for compiling and communicating the hygiene practices of employees within your facility. The mesh network is comprised of:

- Badges are worn on individual employees
- Asset tags attached to assets that should be tracked
- Hygiene sensors mounted to hygiene dispensers track employee hand sanitation frequency
- Entry sensors installed indoor thresholds to provide real-time feedback
- Location hubs monitor employee presence in patient rooms and asset locations
- The communication hub located on each unit collects the data generated within the network and transmits it to the cloud.
- Once the data is uploaded to the cloud, it is accessible to all administrators.

### Product Description

This is a wall-mounted device that is placed inside each of the patient areas and non-patient areas. This device measures the signal strength of badges located near it and transmits the information to the communication hub for processing. It also functions as a powered relay node for Hygiene and Entry Sensors installed beyond the range of the communication hub alone. A picture of an installed Location Hub is provided in Figure 1.

### Installation Procedure

Proper usage of the Location Hub is dependent upon proper placement within the designated room. This is identified by choosing a location within the room that a healthcare provider will be facing when interacting with the patient.

1. If the Location Hub is not pre-assigned:

- Identify the best outlet/power supply by following the “Location Optimization” guide below.
  - Record the serial number and add the Location Hub to the Unit Device Map, ensuring placement on the map reflects the chosen outlet location.
2. Use the pre-applied mounting tape and bracket to ensure solid connectivity to the power outlet.
  3. Make sure the Location Hub is aligned correctly so that the blue LED light is pointed toward the ceiling.
- NOTE:** Install either in the top outlet for two outlet fixtures or the top left outlet for four outlet fixtures.
4. The blue light will slowly blink once it is communicating with the communication hub.

### Location Optimization

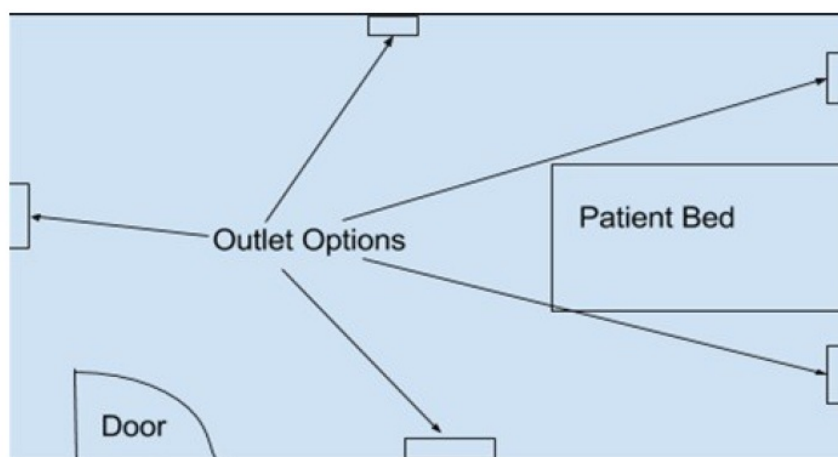



Figure 2: Patient Room

If a comprehensive assessment has not been completed, identify the outlet/power supply as needed. Refer to Figure 2, for a diagram identifying the best options, which are the ones closest to the patient. Choose locations:

- with a clear line of sight of the patient,
- that the healthcare provider is likely to face while interacting with the patient,
- avoid obstructions like medical or patient equipment and belongings, and
- that are not in the corners which will reduce the monitoring field of the Location Hub.
