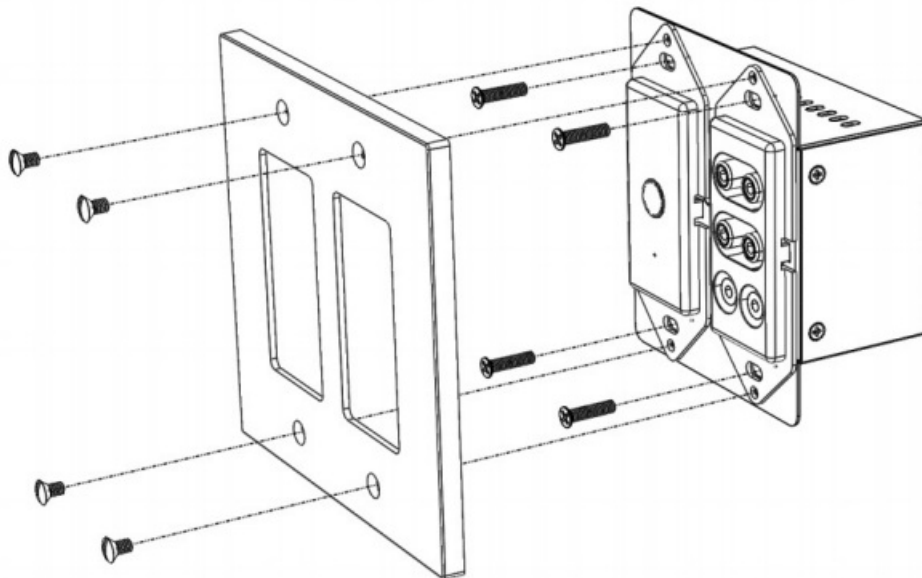

Installation

Hardware Installation

- Connect CAT5e/CAT6 cable to RJ45 port on the rear 1 panel of the xIO Bluetooth RCA-3.5
- Secure the xIO Bluetooth RCA-3.5 to a standard US dual-gang wall box using the included #6-32 x 5/8" Phillips countersunk screws.
- Secure the Decora® plate to the front panel of the xIO Bluetooth RCA-3.5 using the included #6-32 x 1/4" slotted oval head screws (black or white).



Software Installation

composer is the software that provides real-time set-up and control of the xIO Bluetooth RCA-3.5 from a Windows PC environment. Use the following procedure to install Composer™ on your computer.

- From the Symetrix web site (<http://www.symetrix.co>):
- Download the Composer™ software installer from the Symetrix web site.
- Double-click on the downloaded file and follow the onscreen directions to install.
- After installing the software, refer to the Help File for full connection and configuration information.

PHY Dante Devices

This device does not have an internal Ethernet switch. The Ethernet jack is connected directly to the Dante PHY (Ethernet physical transceiver), as opposed to through a switch. This means you must connect the Dante port to an Ethernet switch before connecting it to another PHY Dante device to avoid audio dropouts on Dante channels. Dante PHY devices include many

Ultimo-based devices on the market as well as the specific Symetrix hardware listed below:

- Prism (4×4, 8×8, 12×12, and 16×16)

System Setup

A successful system setup requires that you first establish communications with an Radius NX, Prism, or Edge unit.

Basic Connections

- Connect your PC to an Ethernet port on the Radius NX, Prism, or Edge unit.
- To power the xIO Bluetooth RCA-3.5, connect the Dante port to a PoE injector or PoE enabled switch port.
- Daisy chain a CAT5/6 cable from either the LAN port on the PoE injector or from the PoE switch.

Network Setup

About DHCP

xIO Bluetooth RCA-3.5 boots with DHCP enabled by default. This means that as soon as you connect it to a network, it will look for a DHCP server in order to obtain an IP address. If a DHCP server is present, xIO Bluetooth RCA-3.5 will obtain an IP address from it. This process may take several minutes. With your PC attached to the same network, and thus getting its IP address from the same DHCP server, all will be ready to go. When there is no DHCP server present to assign IP addresses to the xIO Bluetooth RCA-3.5, and you are using Windows default network settings, your PC will set an IP in the range of 169.254.x.x with a Subnet Mask of 255.255.0.0 in order to communicate with the device. This default setting to an Automatic Private IP Address in the range of 169.254.x.x uses the last four alphanumeric characters of the device's MAC address (MAC address hex value is converted to decimal for IP address) for the x.x values. For reference, the device's MAC address can be found on a sticker on the bottom of the hardware. Even if the PC's default settings have been changed, xIO Bluetooth RCA-3.5 will try to establish communications by setting up appropriate routing table entries to reach devices with 169.254.x.x addresses.

Connecting to xIO Bluetooth RCA-3.5 from a host computer on the same LAN

The xIO Bluetooth RCA-3.5 and the host computer require the following 3 items:

- IP Address – The unique address of a node on a network.
- Subnet Mask – Configuration that defines which IP Addresses are included in a particular subnet.
- Default Gateway (optional) – The IP address of a device that routes traffic from one subnet to another. (This is only needed when the PC and xIO Bluetooth RCA-3.5 are on different subnets).

If you are putting xIO Bluetooth RCA-3.5 on an existing network, a network administrator will be able to provide the above information or it may have been provided automatically by a DHCP server. For security reasons, it is not recommended to put xIO Bluetooth RCA-3.5 directly on the Internet. If you do, a network administrator or your Internet Service Provider can provide the above information. If you are on your own private network, directly or

indirectly connected to the xIO Bluetooth RCA-3.5, you may allow the device to choose an automatic IP address or you may choose to assign it a static IP address. If you are building your own separate network with static assigned addresses, you may consider using an IP Address from one of the "Private-Use" networks noted in RFC-1918:

- 172.16.0.0/12 = IP Addresses 172.16.0.1 through 172.31.254.254 and a Subnet Mask of 255.240.0.0
- 192.168.0.0/16 = IP Addresses 192.168.0.1 through 192.168.254.254 and a Subnet Mask of 255.255.0.0
- 10.0.0.0/8 = IP Addresses 10.0.0.1 through 10.254.254.254 and a Subnet Mask of 255.255.0.0

Configuring IP Parameters


Locating Hardware


Discovery of, and connection to, xIO Bluetooth RCA-3.5 hardware is done with the Locate Hardware dialog found under the Hardware menu or by clicking the Locate Hardware icon in the tool bar or on a particular xIO Bluetooth RCA-3.5 unit itself.


IP Configuration with Composer

The Locate Hardware dialog will scan the network and list available units. Select the xIO Bluetooth RCA-3.5 unit you wish to assign an IP address to and click the Properties button. If you wish to assign xIO Bluetooth RCA-3.5 a static IP address, select "Use the following IP address" and enter the appropriate IP Address, Subnet mask and Gateway. Click OK when finished. Now, back in the locate hardware dialog, ensure the xIO Bluetooth RCA-3.5 device is selected and click "Select Hardware Unit" to use this xIO Bluetooth RCA-3.5 hardware in your Site File. Close the Locate Hardware dialog.

Reset Switch

-  To be used under the supervision of technical support, it has the ability to reset the xIO Bluetooth RCA-3.5's network configuration and completely reset the unit to factory defaults. Locate the reset switch through the vents on the bottom side of the T-10 Glass rear cover.

-  Short press and release: Reboots the unit.
- Long press and hold, release when unit reboots:
 - Resets network configuration, returns to DHCP.

-  Apply power while holding, release after unit boots then reboots: Factory resets unit.


