Product Information:

The INFINITE MINI SAMPLE SUSTAINER is a TonePrint pedal designed to provide sample and sustain effects with simple controls and a tiny footprint. The product has a V 2.0 version and comes with safety instructions that must be followed to ensure safe usage. The product is not to be used near water, should only be cleaned with a dry cloth, and should not be installed near heat sources or in confined spaces. The product should only be used with attachments/accessories specified by the manufacturer and should be disposed of correctly according to the WEEE Directive (2012/19/EU) and your national law.

Product Usage Instructions:

To use the INFINITE MINI SAMPLE SUSTAINER, follow the below instructions:

- 1. Connect your guitar to the input jack of the pedal.
- 2. Connect the output jack of the pedal to your amplifier.
- 3. Turn on the pedal by pressing the footswitch.
- 4. Use the sustain control knob to adjust the level of sustain effect.
- 5. Use the sample control knob to adjust the level of sample effect.
- 6. Experiment with different settings to find your desired sound.
- 7. When finished, turn off the pedal by pressing the footswitch again.
- 8. Store the pedal in a safe and dry place.

Note: Follow the safety instructions provided in the user manual to ensure safe usage and disposal of the product.

Safety Instruction


- 1. Read these instructions.
- 2. Keep these instructions.

- 4. Follow all instructions.
- 5. Do not use this apparatus near water.
- 6. Clean only with dry cloth.
- 7. Do not block any ventilation openings. Install in accordance with the manufacturer's instructions.
- 8. Do not install near any heat sources such as radiators, heat registers, stoves, or other apparatus (including amplifiers) that produce heat.
- 9. Use only attachments/accessories specified by the manufacturer.
- 10. Use only with the cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the apparatus. When a cart is used, use caution when moving the cart/apparatus

- 12. Do not install in a confined space, such as a book case or similar unit.
- 13. Do not place naked flame sources, such as lighted candles, on the apparatus.

Controls



- 1. LEVEL Controls the output volume of the effect.
- 2. FADE IN Controls the fade-in rate of sustain effect layer.
- 3. Output
- 4. Footswitch Activates/deactivates sustain layer. Press and hold during power-up to toggle between momentary

(MOMEN) and latching (LATCH) footswitch control:

- MOMEN Press and hold to activate sustain layer. Release to deactivate sustain layer.
- LATCH Press to activate/deactivate sustain layer.
 Double tap to clear memory.
- 5. VERB LED Illuminates when the reverb is active.
- 6. USB Connects to your computer or mobile device for use with the TonePrint App and for firmware updates.
- 7. Power Input Connect a standard 9 V / >100 mA power supply.
- 8. DECAY Controls the fade out rate of the sustain effect layer.
- 9. Main LED Illuminates when the sustain effect is active (red = latching; green = momentary).
