



Controls


- 1. Input/Output jacks Connect a ¼" cable from your guitar to the INPUT jack, and connect a cable from the OUTPUT jack to your amplifier.
- 2. 9 V DC Connect a 9 V power supply (not included).
- 3. Footswitch Turns the effect on and off. The LED will light when the pedal is engaged. The pedal operates in true bypass when disengaged.
- 4. Reverb Adjusts the amount of decay.
- 5. Mix Adjusts how much of the effect is mixed with the dry signal.
- 6. Tone Adjusts the brightness of the reverb.
- 7. 3-position switch Selects the type of reverb effect.
