## Safety Instruction

1. Read these instructions.
2. Keep these instructions.
3. Heed all warnings.
4. Follow all instructions.
5. Do not use this apparatus near water.
6. Clean only with dry cloth.
7. Do not block any ventilation openings. Install in accordance with the manufacturer's instructions.

8. Do not install near any heat sources such as radiators, heat registers, stoves, or other apparatus (including amplifiers) that produce heat.
9. Do not defeat the safety purpose of the polarized or grounding-type plug.  
A polarized plug has two blades with one wider than the other. A grounding-type plug has two blades and a third grounding prong. The wide blade or the third prong are provided for your safety. If the provided plug does not fit into your outlet, consult an electrician for replacement of the obsolete outlet.
10. Protect the power cord from being walked on or pinched particularly at plugs, convenience receptacles, and the point where they exit from the apparatus.
11. Use only attachments/accessories specified by the manufacturer.
12.  Use only 3 with the cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the apparatus. When a cart is used, use caution when moving the cart/ apparatus combination to avoid injury from tip-over.
13. Unplug this apparatus during lightning storms or when unused for long periods of time.

## Controls



1. **Shape Control** – Choose the perfect amount of Adaptive Shape EQ for your vocal.
2. **Mic Input Level Control**
3. **Effect Active LED**
4. **Effect On/Off Footswitch**
5. **USB** – Accepts the included mini-USB cable for firmware update.
6. **Power** – Connect the included 12 V /  $\geq 400$  mA power supply.
7. **Input Level LED** – Green = signal, red = clip.
8. **Mic Control** – Use the optional MP-75 mic (button in = on).
9. **Warmth Button**– Add extra low-frequency fullness to your vocal sound.
10. **Comp/De-ess Control** – Choose your ideal combination of compression and de-essing to control dynamics.
11. **Out** – Connect to a mixer or powered speaker.
12. **Mic** – Connect your microphone.


