### **SAFETY**

#### **WARNING**

- High voltage! Make sure the controller is disconnected from the mains before performing any activities involving the power supply (plugging cables, installing the device etc.) The device should be installed by a qualified electrician.
- Before starting the controller, the user should measure earthing resistance of the electric motors as well as the insulation resistance of the cables.
- The controller should not be operated by children.

#### **WARNING**


- The device may be damaged if struck by a lightning. Make sure the plug is disconnected from the power supply during storm.
- Any use other than specified by the manufacturer is forbidden.
- Before and during the heating season, the controller should be checked for condition of its cables. The user should also check if the controller is properly mounted and clean it if dusty or dirty.

# **DEVICE DESCRIPTION**

EU-L-5s controller is intended for controlling thermoelectric actuators on the basis of the signal sent by the room temperature regulators. The controller can manage actuators via 8 two-state room temperature regulators. The controller has a WT 6,3A tube fuse-link protecting the power supply.

WARNING Higher amperage fuse should not be used as it may damage the controller

- 3. An icon indicating voltage-free contact operation
- 4. An icon indicating that the controller is connected to the power supply

# **HOW TO INSTALL THE CONTROLLER**


# **WARNING**

- Incorrect connection of cables may lead to controller damage.


The device should be installed by a qualified electrician.


# The diagrams below illustrate correct connection:


• Connection of a regulator – 230V

# MAINTENANCE, TECHNICAL DATA

Before and during the heating season, the EU-L-5s controller should be checked for condition of its cables. You should also check if the controller is properly mounted and clean it if dusty or dirty.
