

Before Use




Please check whether your computer has internal Bluetooth


Press the "Windows"+ "X" to select "Device Manager" from the menu that appears. Tip: You can also right click "This PC" > "Manage" > "Device Manager".

Then right click on "Intel(R) Wireless Bluetooth" and select "Disable device".

Default Bluetooth: Generic Bluetooth Radio, Intel(R) Wireless Bluetooth (R).




Use and Connect



Plug the Bluetooth adapter into the USB port of the computer.

Note: This adapter only supports Windows 8.1/10/11 and has no need to install drivers

Select "Add Bluetooth or other devices" to scan for available devices. Please ensure the Bluetooth of the device is turned on.



Troubleshooting

- 1. What can I do if the Bluetooth icon doesn't appear?
 - 1. Ensure there are no other Bluetooth devices installed on the computer. If there are, disable all existing Bluetooth devices in "Device Manager", then insert the adapter and try again.
 - 2. Sometime the Bluetooth icon may be hidden: select "Start" > "Settings" > "Devices" > Click "More Bluetooth Options" > "Options" > Check "Show the Bluetooth icon in the notification area".
- 2. Why can't I find my Bluetooth device?
 - 1. Please make sure that your device supports Bluetooth.
 - 2. Please ensure your Bluetooth device is in pairing mode.
 - 3. Keep your Bluetooth device around/near the adapter at a range of 20m.
 - 4. Please replug the adapter.

3. Can the adapter connect to more than one device at a time?

The adapter can connect to 5 Bluetooth devices simultaneously, such as Bluetooth headphones/speakers, keyboards, mousse, game controller, and phones. However, of the 2 Bluetooth audio output devices (like headphones/speakers), only one will work.


Notes


Click on "Yes" to disable the internal Bluetooth.



Right-click the in the task bar and choose "Add a Bluetooth Device" or select "Start" > "Settings" > "Devices"



Select your Bluetooth device from the list and follow the on-screen instructions to complete pairing.
