FAQ

- Can I use VEEV ONE™ pods with other devices?
- No, VEEV ONE™ pods are specifically designed for use with the VEEV ONE™ device only.
- What should I do if I experience an adverse reaction to VEEV ONE™ pods?
- Stop using the product and seek medical attention immediately. You may also report the incident to your local

Customer Care.

- How should I dispose of VEEV ONE™ pods?
- Dispose of them at a designated collection point for electronic waste as per EU and EEA regulations.
- Is it safe to fly with VEEV ONE™ pods?
- Due to the risk of leakage with altitude changes, it is not recommended to fly with VEEV ONE™ pods that have been removed from packaging or partially used.
- What are the risks associated with nicotine in VEEV ONE™ pods?
- Nicotine is addictive and can lead to health risks. It is not recommended for use by certain groups including pregnant women, individuals with heart diseases, diabetics, epileptics, or those experiencing seizures.

## Introductions

- You can change the VEEV ONE™ pod while your VEEV ONE™ device is turned on. When you insert the VEEV ONE™ pod, status lights will turn on slowly. You can use your VEEV ONE™ device.
- VEEV ONE™ pods are designed to be used only with VEEV ONE™ devices. Liquid droplets visible on the cartridge or mouthpiece, which may occur during unpacking or usage, must be wiped off with a clean dry cloth before use.
- Do not use the VEEV ONE™ pod if it appears to be damaged, tampered with, broken, or leaking.

This is the safety alert symbol. It is used to alert you to potential physical injury hazards.

## Nicotine

- VEEV ONE™ pods contain nicotine, which is addictive.
- VEEV ONE™ and VEEV ONE™ pods are not risk-free. The best way to reduce nicotine-related health risks is to quit tobacco and nicotine use altogether.

- Some users may experience side effects including abdominal pain, cough, dizziness, dry mouth, headache, malaise, nasal stuffiness, nausea, mouth irritation, throat irritation, and vomiting.
- Nicotine-containing products should not be used by people who have or are at risk of heart disease, are diabetic, are epileptic, or are experiencing seizures.
- Nicotine-containing products should not be used during pregnancy or while breastfeeding. If you are pregnant, breast-feeding or think you may be pregnant, you should quit nicotine use altogether.
- Stopping smoking or switching to VEEV ONE™ and VEEV ONE™ pods or other nicotine-containing products may require the adjustment of the dosing of certain medicines (e.g., theophylline, clozapine, ropinirole).
- If you have questions about whether you should use VEEV ONE™ and VEEV ONE™ pods given an existing health condition, you should consult a healthcare professional.

## **IMPORTANT SAFETY INFORMATION**

### **WARNING | Choking and Ingestion Hazard**

- Keep VEEV ONE™ and VEEV ONE™ pods out of reach of children and pets at all time
- **CHOKING HAZARD** — VEEV ONE™ device, accessories, and VEEV ONE™ pods contain small parts.  
**INGESTION HAZARD:** If VEEV ONE™ pods are swallowed, seek medical attention immediately due to risk of nicotine intoxication.
- If e-liquid is ingested, rinse your mouth and seek medical attention.

### **CAUTION! Irritation Risk**

- Avoid contact of e-liquid with skin and eyes. In the event of:
- Skin contact: wash immediately with soap and water.
- Eye contact: rinse carefully with water for several minutes.
- Contaminated clothing: wash before reuse.

### **Use of VEEV ONE™ pods**

- Only use VEEV ONE™ with VEEV ONE™ pods specifically designed for VEEV ONE™. Never use VEEV ONE™ with other pods. Doing so may cause injury.
- Do not modify or attempt to refill VEEV ONE™ pods in any way or add any substance to VEEV ONE™ pods. Doing so may cause injury.

### **Storage**

- Store in the original packaging at room temperature.
- Use VEEV ONE™ pods promptly once removed from the original packaging.
- Do not use this product if it has been exposed to excessive cold, heat, or moisture.
- Droplets or traces of liquid may appear during usage, storage, or unpacking of VEEV ONE™ pods. Should you see droplets or traces of liquid on a pod or VEEV ONE™, without signs of leakage, carefully and thoroughly wipe the residue before use with a dry cloth (including the mouthpiece and contacts). Do not use the pod if it is actively leaking, or if any droplets or traces of liquid reappear after cleaning.
- Do not use this product if the VEEV ONE™ pod appears to be damaged, tampered with, broken, or leaking.
- Due to the risk of VEEV ONE™ pods leaking with altitude changes, it is not recommended to fly with VEEV ONE™ pods that have been removed from packaging or have been partially used.
- Store in a place inaccessible to children.
