2P+E 5 A 250 V~ SICURY socket outlet, English standard with 2P 1-way switch, complete with frame for installation in British standard square mounting boxes, to be completed with 3-module British standard cover plate.

Eikon 20215.L - Arké 19215.L - Plana 14215.L: indicator unit supplied.

Eikon 20215 - Arké 19215 - Plana 14215: indicator unit not supplied.

To replace or insert the indicator unit (00930), proceed as illustrated in figures 3, 4, 5, 6 and 7.

- Fixing screws in the vertical: fig. 1
- Fixing screws in the horizontal: fig. 2

Each terminal is suitable for rigid or flexible conductors (3×2,5 mm², 3×4 mm², 2×6 mm²). Suitable for BS4662 1-GANG MOUNTING BOX with 25 mm depth.



# INSTALLATION RULES.

- Installation should be carried out by qualified personnel in compliance with the current regulations regarding the installation of electrical equipment in the country where the products are installed.
- Disconnect the mains acting on the main switch before operating on the system (fig. 3).





### **WEEE – Information for users**







