Thank you for purchasing the Mouse Shaped Wireless Mouse, item CM-ES15-MS. A 2.4GHz USB receiver is included inside of your mouse. Please read this manual carefully FIRST in order to get the most out of your mouse.

## **INSERTING THE BATTERY**

In order to operate your mouse successfully, you will need to insert 1 AA battery (not included). To do so, follow the steps below.

- 1. Open the battery compartment cover sideways to reveal the battery compartment. The battery compartment cover is located on the bottom of your mouse.
- 2. Insert 1 AA battery inside the battery compartment, making sure to insert it with the correct polarity (+,-) as shown on the battery compartment.
- 3. Once your battery is properly inserted, you can put the battery compartment cover back on your mouse.

## **BATTERY WARNING:**

- · Do not mix old and new batteries.
- Do not mix alkaline, stand (carbon-zinc) or rechargeable (Nickle-cadmium) batteries.
- Batteries are not to be inserted with the wrong polarity.
- Exhausted batteries are to be removed.
- The supply terminals are not to be short-circuited.
  Please recycle or dispose of the battery properly. Contact local recycling facilities and/or the manufacturer of your battery for further information.


## **MOUSE SETUP**

In order to connect your mouse to your computer, follow the steps below:

- 1. Remove the USB receiver from the storage slot inside the battery compartment on the bottom of your mouse.
- 2. Insert the USB receiver into one of your computer's USB ports.
- 3. Make sure that your computer is powered on.


