Instructions

Intended Use

- 1. **SPACE:ON** provides purpose-suited lighting to specific areas.
- 2. SPACE:ON is for charging a receiver equipped with an RF wireless receiving circuit.
- 3. **SPACE:ON** wireless charging can only be used compatible with devices that contain a receiving circuit for charging the receiver, regardless of whether there is a battery or not.
- 4. This device is for indoor use only.

User Operation

- 1. **SPACE:** ON can turn the lighting on/off with the power switch.
- 2. **SPACE:** ON can only turn on/off the RF wireless transmitter.

3. $\ensuremath{\mathbf{SPACE}}\xspace$ ON can only turn the lighting on/off.

 - A: The status LED will indicate whether the RF wireless transmitter is on or off based on the provided touch sequences.
