To turn on the device, press and hold the Side key for a few seconds.



The charger should remain close to the electric socket and easily accessible while charging.

If your device is frozen and unresponsive, press and hold the Side key and the Volume Down key simultaneously for more than 7 seconds to restart it.

- It is recommended not to use fixed graphics on part or all of the touchscreen for extended periods. Doing so may result in afterimages (screen burn-in) or ghosting.



To prevent possible hearing damage when using a headset, do not listen to sound at high volume for long periods.

Depending on the region, you can view the regulatory information on the device. To view the information, launch the Settings app.

Specific Absorption Rate (SAR) certification information

Your device conforms to U.S. Federal Communications Commission (FCC) standards that limit human exposure to radio frequency (RF) energy emitted by radio and telecommunications equipment. These standards prevent the sale of mobile devices that exceed a maximum exposure level (known as the Specific Absorption Rate, or SAR) of 1.6 W/kg.

In normal use, the actual SAR is likely to be much lower, as the device has been designed to emit only the RF energy necessary to transmit a signal to the nearest base station. By automatically emitting lower levels when possible, your device reduces your overall exposure to RF energy.

The FCC has granted an Equipment Authorization for this model device based on the compliance of all reported SAR levels with the FCC RF exposure guidelines. Some devices are required to receive approval from the FCC. If your device required FCC approval, you can view the FCC certification by opening Settings About phone Status.
