



WiZ Camera module is offered as a Connected module which can be integrated into Luminaire, offering the Home Monitoring proposition next to Connected lighting.





- 2. The WiZ camera module should be powered with a Limited Power Supply (LPS) only according to UL IEC 62368 or equivalent. Please consult WiZ for more details if necessary.
- 3. It is the manufacturer's responsibility of end products to ensure the full compliance of the final integration applications (i.e end products).
- 4. Please clean the camera lens gently with a cotton cloth and avoid touching the lens with hands directly to ensure clear view.
- 5. Please regularly clean the dust on microphone and speaker to ensure 2-way audio quality.
- 6. The WiZ camera module does not provide third-party monitoring or emergency response. It is the user's responsibility to determinate the appropriate response.
- 7. The WiZ camera module is limited to a user's own, private residential use.
- 8. The user is responsible to comply with privacy and other applicable laws.
