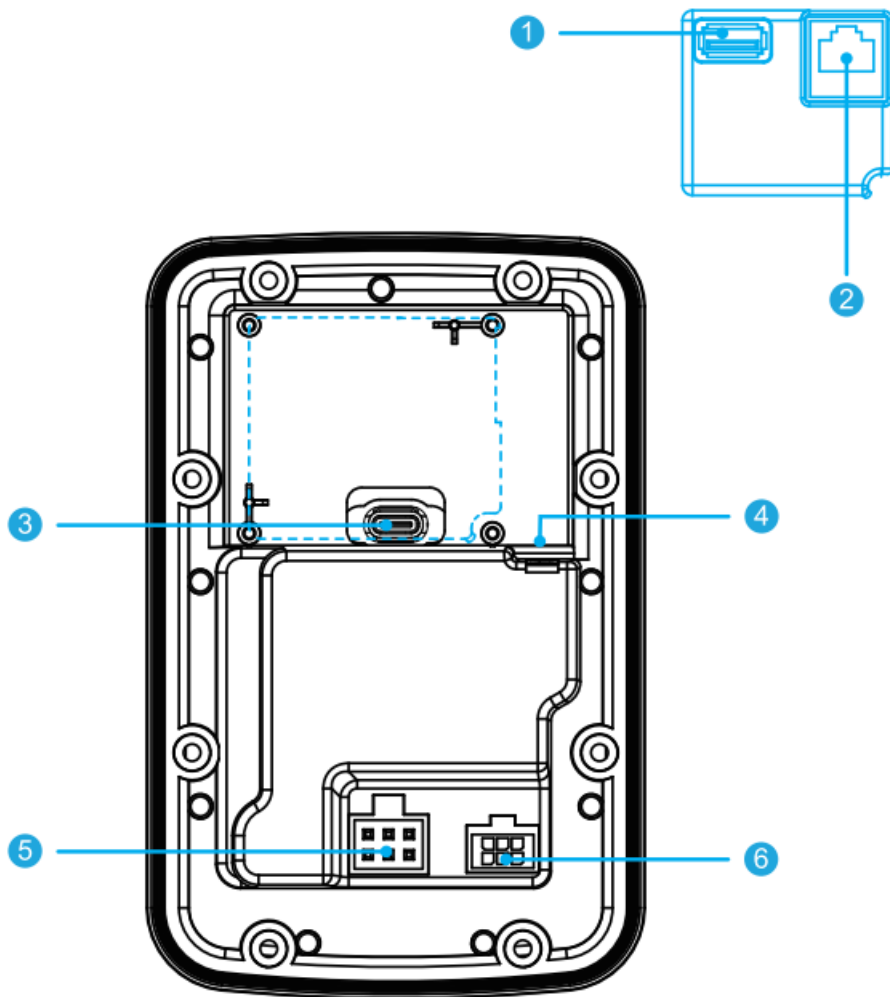

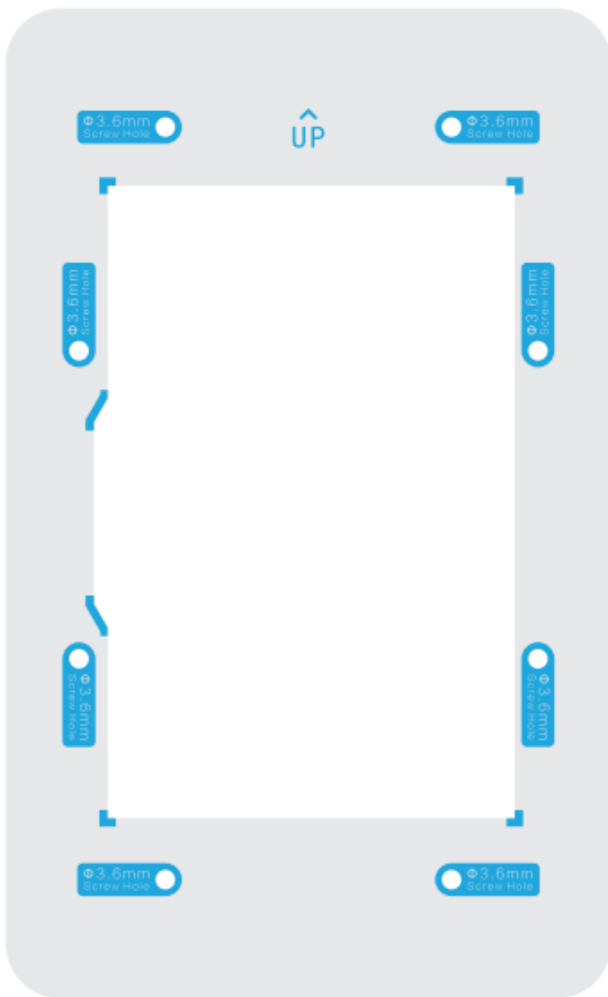

## Open Battery Compartment Cover

### Before use

- Please check if the configuration is consistent with the requirements;
- Please check whether the accessories are complete, including data cables and punch templates;

### Power on and off

- This product supports 12-24V DC or MDB power supply;
- After the product is powered on, it will automatically turn on and is always running;
- When the product needs to be restarted, please cut off the power first and then power on again;

### System setup

Click the "setup" icon on the desktop to setup the system.  
You can set up the POS as needed.

### Payment operation

Please follow the instructions of your payment App provider.

## Bank card operation

- Please insert the IC card face up into the IC card reader.
- Swipe the magnetic stripe card with magnetic stripe facing to screen, you can bi-directionally swipe the card.
- Tap the contactless card close to the contactless quickly area to read the card.

## Installation Guide

- Attach the template with mounting holes of the surface of the vending machine and mark the holes.



- Punch holes according to the marks.



- Fix the Q3V with screws and connect the MDB cable to the control board of the vending machine.



- Power on and run after installation.
