





### **Maximum channel latch**




- 1. Use the "<" or ">" channel button to select the maximum channel (except the teamwork channel "00").
- 2. Hold down the "<" and ">" channel buttons at the same time, the screen will start flashing the current channel until 'AA' is displayed.
- 3. The screen displays "AA" as successful

#### Release the maximum channel latch



- Except for the teamwork channel "00", hold down the "<" and ">" channel buttons.
- The display starts flashing the current channel and lets go until "15" is displayed
- When "15" is displayed, the operation succeeds.

## **Battery replacement**



- 1. Loosen the rear cover screws, and slide down to open the battery compartment.
- 2. Remove the old batteries and properly dispose of the used ones.
- 3. Place the battery right side up in the battery compartment.
- 4. After sliding into the back cover, tighten the screws.

#### Warning

- 1. Keep the Transmitter away from moisture and impact to extend the service life.
- 2. If it is found that the Transmitter needs to be closely controlled or the button is not too sensitive, and the indicator light blinks and dims, the battery needs to be replaced.
- 3. Press any button for more than 10 seconds, and the Transmitter will stop sending wireless signals.
- 4. Please dispose of used batteries properly.
- 5. The 00 channel can control all channels, and the code matching function cannot be realized when using this channel.
